1. Applications are invited as specified by the Chairman, Balurghat Municipality, P.O- Balurghat, Dist- Dakshin Dinajpur. Invites e-QUOTATION (Electronic Quotation) from eligible resourceful & bonafied contractors for the year 2022-2023.
2. Applicants willing to take part in the process of e-Quotation will have to be enrolled & registered with the Government e-Portal system through logging on to <https://wbenders.gov.in> using the option —Click here to Enroll. Possession of a Valid Class II Digital Signature Certificate (DSC) in the form of smart card/e-token in the Company's name is a prerequisite for registration and participating in the Quotation submission activities through this web site. Digital Signature Certificates can be obtained from the authorized certifying agencies, details of which are available in the web site <https://wbenders.gov.in>
3. Intending quotationers can search and download NleQ and other tender documents electronically by logging on to the website <https://wbenders.gov.in>, using his Digital Signature Certificate (DSC). This is the mode of collection of quotation documents electronically.
4. For participating in the tender, the earnest money will be deposited by the bidder through the following payment mode as per Finance Department Order No. 3975-F(Y) dated 28<sup>th</sup> july, 2016 (Annexure – A) – a) Net banking (any of the banks listed in the ICICI Bank Payment gateway) in case of payment through ICICI bank payment gateway. b) RTGS/NEFT in case of offline payment through bank account in any bank. Tender will be declared informal if Earnest money is not submitted as directed above.
5. *A prospective Quotationers shall be allowed to participate in the job either in the capacity of individual or as a partner of a firm. If found to have applied severally in a single job all his applications will be rejected for that job.*
6. **Eligibility criteria for participation in Quotation:**
  - i) The prospective Quotationers who are eligible to participate (Manufacturer / Authorized Dealer of a reputed company/Supplier etc.) should have sufficient resources, financial solvency, sufficient experience during the last 5 (five) financial years prior to the date of issue of this Notice single similar nature work under the State/Central Govt. Undertaking, Board/Corporation, Local Bodies or similar Govt. Organization etc., having a credential of a similar nature of completed work of at least 40% of the quoted amount put in quotation or 2 (two) similar nature of completed work, each of the minimum value of 30% of the quoted amount put in quotation or one single running work of similar nature which has been completed to the extent of 80% or more and value of which is not less than the desired value i.e, 40% of the quoted amount put in quotation. Scanned copy of Payment certificates or completion certificates issued by the Concerned Executing Authority should be uploaded as Non-Statutory Document through online.

**7. Submission of Quotations**

**7.1 General process of submission**

## GENERAL TERMS AND CONDITIONS OF AGREEMENT

**A. Finishes & Requirements:** The Locations where the Open Air Gym Equipment's can be installed to be intimated in the Work order along with the requirements. Than the successful bidder will make foundation, etc. as per the requirements for installation of Gym equipment's. The firm shall install the equipment's in the said locations at its own cost and expenses. **The quality of equipment's and its foundation should be of very high standards as per the General Technical Specification mentioned in the below table.**

<b>GENERAL TECHNICAL SPECIFICATION FOR THE EQUIPMENTS</b>	
<b>User Weight</b>	The fitness equipment should for minimum 120 kg or more user weight.
<b>Safety and Quality standard</b>	The outdoor fitness Equipment's should be confirming to the required standard for safety and quality as per DIN/ASTM/CPSC/ES/BIS.
<b>Anti-Rust</b>	Shot blast /grit blasting of equipment to clean the rust Electrostatic power coating technique: to process the pipe Surface.
<b>Column</b>	The mild steel pipe, column footing plate with a pull-burst, the surface rust, acid degreasing, cleaning, phosphate rust after a several process, throwing sand, imported plastic powder with a double surface household level spraying layer, electronic spray, high temperature plastic200 degree baking powder, smooth surface, UV resistant or as specified by the manufacturer's specification.
<b>Seat on plastic</b>	LLDPE/HDPE/metal with any protection/composite material with any protection infiltration of anti-ultraviolet, anti- static decolourization element passing, strength, smooth surface, security assurances, weather resistance etc.
<b>UV</b>	Fully UV resistant.
<b>Platforms</b>	High strength punching plate, with a special process dealing with wavy surface microscopy, safe, and beautiful non slip resistance.
<b>Fasteners</b>	Stainless steel screws to be used, and at the contact point with the columns- rubber pads to be used , screw top cover with a plastic cap, to enhance its security.
<b>Colour Scheme</b>	All equipment should be of similar colour.

The Rate contract will be valid for a period of one year from the date of finalization of rate contract. However, the approx. quantity requirement is mentioned in the below table, which may increase or decrease to an extent of 50%. The bidders are expected to quote their best rates for the equipment's. **B. Payment Terms:** The payment will be released in two instalments first 90% after satisfactory Supply and Installation at the locations and rest 10% after completion of Defect Liability Period of Two Years. The contract cost shall final and binding. No price escalation shall be entertained on any account whatsoever.

**C. Safety and Security Measures:** Bidders shall be responsible at its own cost, for procurement, transport, receiving, unloading and safe keeping of all equipment's and other things required for the installation and operation & maintenance of the equipment's during Defect Liability Period.




